

REQUEST FOR PROPOSAL FOR A CONSULTANT ON QUALITY CONTROL FOR WOOD PRODUCT TESTING WORK - RFP/GA /QUALITY CONTROL-WOOD/JULY- 2024 -001

1. ABOUT GATSBY AFRICA

2. PURPOSE OF THE ASSIGNMENT:

To conduct two quality control exercises for the wood supplied for testing at the University of Stellenbosch.

3. SCOPE OF THE WORK

The scope of work involves checking 10% (323) of 3,230 lamellas (planks of wood) cut in 3 distinct cross sections:

- 25*100*3000
- 38*150*3600
- 50*150*3600

The wood is sourced from both Uganda and Tanzania and is of the species Pine Patula, Pine caribaea, Eucalyptus grandis and Eucalyptus grandis x urophylla. The wood will be measured against the following defects:

Surface checks	All allowed	
Discoloration	Bluestain allowed, brown or red discoloring that is firm against manual pressure allowed, brown or white rot not allowed	
Resin Infiltration	Minimal allowed	
Cross-fracture	None allowed	
Decay (away from knots)	None allowed	
Insect damage	None allowed	
Mechanical damage	Notches up to 5 mm deep allowed; end splits: max 150mm length, but only 1 at each end or 2 at one end.	

4. KEY DELIVERABLES

The key deliverables include, two separate quality checks the first checking 10% of the total lamellas (323), the second 10 lamellas per suppliers' batch just before loading. Quality checks of 323 lamellas in both Uganda and Tanzania will adhere to the following:

- Defects allowed in the table provided (extra attention given to moisture content measures)
- Cross sections highlighted
- Colour codes assigned to each supplier
- Silviculture information

5. SKILLS AND EXPERIENCE REQUIRED

Knowledge on timber processing, defects that occur in timber. Experience in timber yards and forestry would good.

6. MANAGING DELIVERY

The Quality Control firm / Consultant will work with the Head of Technical Services Commercial Forestry and Senior Analyst Commercial Forestry.

7. TIMELINES & SCHEDULE OF ACTIVITIES

First Quality Control should occur 19th of August 2024, the second 2nd of September.

8. PROPOSAL DETAILS:

The following are the minimum qualifications for this RFP. Proposals that do not meet these requirements will not be considered.

- (i) A brief technical proposal detailing your suitability for the assignment.
- (ii) Detailed CVs of the personnel proposed for the assignment.
- (iii) Industry Certifications / Compliance.
- (iv) At least 3 referees to whom similar services have been/are being offered.
- (v) An up-to-date Tax Compliance Certificate / Tax Clearance Certificate
- (vi) An itemized financial proposal detailing the proposed cost of the assignment is enclosed separately.
